Guidance on Summer Music Activities for F-1 Students

Office of International Students & Scholars

This handout provides immigration compliance guidance regarding summer activities prior to arrival on campus, yet while a student is already on Rice-sponsored F-1 visa status. Failure to comply with immigration regulations, including proper work authorization, can result in a termination of your F-1 visa status that would require an immediate departure from the U.S. Therefore, OISS wants to ensure students are aware of regulations affecting their status.

Many activities that take place off campus (paid or unpaid) require work authorization (CPT – Curricular Practical Training or OPT – Optional Practical Training*).

Examples include:

Activity	Authorization Required	Comments
Gigs	Yes	Requires work authorization – see OISS advisor for more information
Giving Lessons	Yes	Requires work authorization – see OISS advisor for more information
Performances	Yes	Requires work authorization – see OISS advisor for more information
Accompaniments	Yes	Requires work authorization – see OISS advisor for more information
Scholarships	No*	Funding, monetary or in-kind (housing/food), does not typically require additional authorization, unless there are work contingencies for the scholarship
Resident Associate at a music festival	Yes	Requires work authorization – see OISS advisor for more information
Music festival participation	Maybe	Requires consultation with an OISS advisor to discuss all variables that may affect immigration status

To ensure immigration compliance, please contact an OISS advisor in advance to discuss summer activity plans. An OISS advisor can offer guidance on all options available to you, including:

- Immigration benefits available to F-1 transfer students *prior* to transferring their record to Rice (e.g. OPT).
- Immigration benefits of being on a festival’s visa program sponsorship (F-1 or M-1).
- Immigration compliant options for summer activities while on Rice F-1 status (Non-employment scholarships).
