Short-term Scholar	A professor, research scholar, specialist, or a person with similar education or accomplishments coming to the United States on a short-term visit for the purpose of lecturing, observing, consulting, training, or demonstrating special skills. 22C.F.R. § 62.4(b) Not subject to repeat participation bars.	1 day	6 months
Visiting Int'l UG Researchers (Non-degree seeking students)	<u>For current undergraduate students only.</u> Visiting international undergraduate level (research-only) students are a special case. They are undergraduate students abroad who come to Rice University for a short visit to engage in experiential research-only learning, often in the summer months. They do not yet have a Bachelor's degree, or Bachelor's degree equivalent, and are not pursuing an undergraduate degree at Rice. C.F.R. § 62.23(h)(2)	3 weeks	24 months



English Language Proficiency Determination Form J-1 Scholars

According to federal regulations, J Exchange Visitors (EV) must possess “sufficient proficiency in the English language...to participate in his or her program *and* to function on a day-to-day basis.” [22 CFR 62.11(a)(2)] Sponsoring institutions are required to determine an applicant’s English proficiency before a DS-2019 can be issued. At Rice, one of the following conditions **must** be met for a J-1 applicant to demonstrate English proficiency.
