

What You Need To Know

HOW DOES THE AMERICAN TAX SYSTEM WORK?

federal government on their revenue or income. In the U.S., this process is completed through a government agency called the Internal Revenue Service (IRS).

AM I REQUIRED TO FILE A TAX RETURN, EVEN IF I DIDN'T RECEIVE ANY INCOME?

Yes, Every international student, scholar, and their dependents (including spouses and children of all ages) are required to file a tax return as a condition of their visa if present in the U.S. during any portion of the previous calendar year, but not everyone will be required to pay taxes to the American government. However, all must complete Form 8843 and file it even if no income was received.

HOW DO I FILE A TAX RETURN?

DETERMINE YOUR RESIDENCE STATUS.

In general, foreign nationals on F, J, M, or Q visas are considered "exempt individuals," which means you considered a non-resident for tax purposes for the first 5 years you are in the US as an international student or the first 2 years as a scholar. After this period you will be subject to the Substantial Presence Test, which is used to determine if you are to be considered a resident for tax purposes

DETERMINE WHETHER YOU NEED AN ITIN.

Did you receive U.S.-based scholarship or fellowship income, but are not employed on or off campus and therefore you do not have a Social Security Number (SSN)? You may require an ITIN issued by the IRS in order to file taxes on this income. This identification is for federal tax reporting only and is not intended to serve any other purpose. An ITIN does not authorize work in the US or serve as

DETERMINE WHETHER YOU HAD ANY INCOME FROM US SOURCES.

If you earned wages from a job in the United States, received scholarship money from an American organization, or made interest on money in an American bank account, you made US source income. The full list of potential income sources can be full list of potential income sources can be

GATHER THE REQUIRED

The forms required depend on your residency status and whether you made US source income in the previous calendar year, whether you need to apply for an ITIN, whether you will claim a tax treaty benefit, and whether you will claim a refund on Social Security and Medicare taxes. All the forms can be downloaded from the IRS website.

GATHER THE DOCUMENTS YOU RECEIVED FROM YOUR INCOME SOURCES. THE MOST COMMON DOCUMENTS ARE

W-2

- MAIL YOUR TAX FORMS, ALONG WITH COPIES OF YOUR W-2'S, 1099'S, AND 1042-S'S, AND A CHECK (IF YOU OWE ANYTHING).

HOW DO I SUBMIT THESE FORMS?

WHEN DO I NEED TO FILE MY TAX RETURN?

The tax deadline is usually the 15th of April, unless that day falls on a weekend, in which case the deadline is extended until the next weekday.

TAKE THESE STEPS NOW **TO MAKE THE 2021 TAX SEASON MUCH EASIER**

You probably don't want to think about next year's taxes right now, but doing so can make the 2021 tax season much smoother. Here are a few steps you should take now to save yourself a headache later.

GET A SOCIAL SECURITY NUMBER

If you have a job, apply for your Social Security Number as soon as possible! You are only eligible to apply for a Social Security Number while you are employed! Social Security Numbers are far easier to get than an ITIN. If you don't have a job, consider getting one!

GET AN INDIVIDUAL TAXPAYER IDENTIFICATION NUMBER (ITIN)

Who needs to apply for an ITIN? Those who are not eligible for a SSN (who have not secured employment and do not plan to do so at this time) and need to file tax returns must apply for an ITIN.

Who is exempt from the ITIN? o Individuals who already have a SSN o Individuals who already have a valid ITIN (valid 5 years from date of issuance)

o Individuals who only need to file IRS Form 8843

ITIN numbers are VERY complicated to obtain during tax season, if you don't plan ahead of time. If you know that you will need an ITIN due to a fellowship or a scholarship, we recommend you work with OISS to request your ITIN (for more details see the ITIN article in this newsletter and check out http://oiss.rice.edu/itin). If you choose to wait until tax season, book an appointment with the IRS Tax Payer

Assistance Center in January. Another option is to obtain a Certified Copy of your passport from your government to mail that in along with the other documents to the IRS.

CHECK YOUR DEDUCTIONS WITH THE PAYROLL OFFICE

If you have a job, money will be deducted from your paycheck to cover your taxes. You may be able to lower your withholding amount depending on how you complete your form W-4 with Payroll. Ask Payroll to explain the amount that is being deducted for taxes, so that you are informed and better prepared for what to expect at tax filing time.

Cool, Calm, and Compliant

These have been crazy times and keeping up with immigration compliance may seem like a difficult task. Here are just a few friendly reminders for F-1 and J-1 visa holders to make sure you are informed regarding your immigration requirements.

Reporting requirements:

Moving? Report your new address in ESTHER within 10 days

Change your phone number? Update ESTHER with your new number within 10 days

Changing majors? Adding a new major? You will receive a new I-20 or DS-2019, if you haven't, please contact OISS.

Traveling? Be sure to get a travel endorsement on your I-20/DS-2019 before you leave and upload a copy of your new I-94 upon your return to the US to http://bit.ly/oissdocs

Need to drop to part-time status? There are limited circumstances that will allow you to receive permission to drop below hours. Please see an OISS advisor before you drop to discuss the particulars of your situation

Need to take a leave of absence? See an OISS advisor for the proper steps regarding your immigration status and Rice process.

Completing your program early? Notify OISS of your early departure for your SEVIS record to be properly closed out.

Need to stay longer? Request an extension from OISS before your immigration documents expire

Online class limits for the Fall 2020 semester? Due to the pandemic, F-1 and J-1 students have more flexibility this semester. While all F-1 and J-1 students must be full-time and making progress towards their degree, the in-person class requirements vary: *New* F-1 and J-1 students who have arrived in the USA must take at least one in-person 3-credit-hour course as part of their full-time coursework, while *continuing students* in F-1 and J-1 status may enroll in online coursework, if necessary, but is dependent upon the discretion of the academic department and program requirements. Students who remain abroad for the fall term may continue enrolled in all online coursework.

Want to work? See an OISS advisor regarding the proper work authorization you need for your particular circumstances, and ALWAYS get work authorization before you begin working. Remember, even unpaid internships still require proper authorization to maintain status

What about old I-20s or DS-2019s? Can they be thrown away? Don't throw away any old immigration documents!! Be sure to keep all current and former immigration documents in a safe place. You will need these records should you ever want to apply for immigration benefits in the future.

<u>Immigration benefits:</u> Immigration benefits such as work authorization, extensions, visa renewals, etc. are not an entitlement. Immigration benefits are options that you may be eligible to request, but there are no guarantees. Stay compliant, keep copies of all supporting documents, and stay tuned to immigration updates from OISS regarding trends and changes in immigration benefit requests.

Ask before you act! Immigration laws are written in a way that require authorization to be done in SEVIS prior to taking the action, so please see an OISS advisor *before* engaging in any activity that may impact your immigration status. The OISS website has information, handouts, procedures, and guidance for our most frequently asked questions – and the OISS staff is here to answer your questions. What is an I-515A and how to avoid it?

Before anybody is getting really scared, let me start with it is not a secret code or another deadly virus. But, before anybody is getting very relaxed, it is not something fun either, and the OISS highly recommends avoiding it.

In seeking entry to the United States any international student, exchange visitor and dependent must show proper documentation at the port of entry, which is reviewed by the Customs and

Border Protection officer to determine admissibility. It seems to be simple and trivial, yet many times students forget their I-20 or DS-2019 documents at home, pack them in their luggage, or the documents may be missing the required travel endorsement. Even though these scenarios are due to innocent human errors, unfortunately, they all have negative consequences which may involve additional questioning, long waiting in a separate room while the officer is checking your records, worrying about your luggage, missing connecting flights, stressing out whether you'll be able to enter at all, and even losing immigration status or denied entry to the US.

If you find yourself in this situation, it is always the discretion of the officer how to proceed who may deny you entry or may issue a Form I-515A to let you in. This is a document that can be provided to students seeking entry into the US without proper documentation. It allows a temporary stay, usually for 30 days, during which you will need to meet with an OISS advisor, and prove your legal status in the US by collecting and mailing additional documents to the agency. Your request then will be adjudicated, and upon favorable decision, your record will be updated with the correct admission status.

Is the I-515A a bad or a good thing? It certainly seems better than not being able to enter the US at all, and it certainly seems worse than entering smoothly. You may decide yourself, but in either case here are 3 simple steps to avoid this scary and cumbersome process:

Always bring all of your original immigration documents with you when traveling Have your documents in your purse or carry on, and do not pack them in your checked luggage Make sure your I-20 or DS-2019 document is signed for travel before you leave the US

If you have AETNA for students

- Aetna will waive co-pays for all diagnostic testing related to COVID-19.
- Aetna is also waiving early refill limits on 30-day prescription maintenance medications for all members.
- Beginning immediately, CVS Pharmacy will waive charges for home delivery of prescription medications. With the CDC encouraging people at higher risk for COVID-19 complications to stay at home as much as possible, this is a convenient option to avoid coming to the pharmacy for refills or new prescriptions.
- Through Aetna's Healing Better program, members who are diagnosed with COVID-19 will receive a care package containing CVS items to help relieve symptoms. The package will also include personal and household cleaning supplies to help keep others in the home protected from potential exposure.
- Out of Pocket Maximum is \$6000 for an individual or \$12,000 for a family.

You are encouraged to use <u>Teledoc</u> for non-emergency care, available at any hour of the day (24/7/365).

If you have SAS for students

- Wellfleet covers treatment based on the members specific plan benefits.
- Wellfleet covers all member costs for all necessary COVID testing at in-network facilities, including emergency room, urgent care, and office visits.

Wellfleet is covering COVID Testing and Treatment as follows:

Testing

- Antigen test (on-site rapid screening and in-lab test for active COVID-19 disease)
- PCR (Polymerase Chain Reaction) test (in-lab test for active COVID-19 disease)
- Antibody (serology) test (in-lab test for immune response to late active or past COVID-19 disease)

Testing is covered under the following conditions:

- The test is medically necessary AND
- The member meets CDC/state requirements for testing AND
- An FDA approved test is utilized as ordered by a qualified provider ("Provider") OR
- State regulations mandate coverage of testing without the above requirements being met.

Wellfleet is covering testing for active disease as noted above, without co-pays, deductibles and co-insurance.

Wellfleet is covering testing for prior disease and immunity as noted above unless regulations state otherwise.

If requesting personal reimbursement, please supply a copy of the receipt.

Treatment - Wellfleet is waiving out-of-pocket costs for all COVID -19 treatment until further notice. Wellfleet will waive all co-pays, deductibles and co-insurance. Similar to a preventative visit, like your annual physical, you'll have no out-of-pocket costs for your treatment.

Wellfleet is covering medically necessary testing and treatment at 100% with no out of pocket costs to the student.

- Letter of invitation for friend or family to visit you in the U.S.
- Special COVID-19 Visa Application Support Letter

OPT "Priority Processing"

Graduating in December?

Stay tuned for information on Priority Processing, a special guarantee by OISS to ensure you'll be able to submit your OPT application to USCIS as early as possible! This year USCIS has proposed an OPT application fee increase which you *may* be able to avoid by using Priority Processing!

By submitting the first part of your OPT application to OISS (i.e. OPT Student Form, OPT Faculty Advisor Form & I-765) by the Priority Processing deadline (to be confirmed via OISS-Announce emails), we guarantee your OPT I-20 will be ready to submit to USCIS at the earliest time when USCIS will allow you to send in your application. Please remember that you don't need a job offer in order to apply for OPT!

Are you receiving a scholarship or fellowship?

Are you a Rice sponsored F-1 or J-1 student receiving a taxable scholarship, fellowship, or grant? Do you have the required SSN or ITIN needed to file your taxes?

If you are receiving funding, but do not yet have a tax identification number (SSN or ITIN), you may be eligible to apply for your ITIN (Individual Tax Identification Number) at OISS through a special provision in US tax law. We highly encourage you to take advantage of this opportunity to be prepared for tax season in April.

OISS will host ITIN Application Sessions in October to assist you with applying for your ITIN, so please stay tuned to OISS-Announce for dates and times and check out http://oiss.rice.edu/itin for details on how to apply.

ITINs can be VERY COMPLICATED to obtain during tax season, so applying early is essential to preventing delays in filing your required U.S. tax return.

By applying for your ITIN early, you will be able to file your taxes on time without the hassle of making an appointment with the IRS to apply for an ITIN during tax season.

By applying for your ITIN early, you will have an easier time completing your tax forms.

By applying for your ITIN early, you can file your taxes on time and have a better chance of receiving any tax refund you may be due.
